

General terms and conditions Glen of Eden Database

Glen of Eden database is a service accessible via internet.

The database contains all relevant information regarding the purebred 'Irish Glen or Imaal Terrier'. In the interest of the breed this information comprises more than the pedigree only and hence, some people might like to use the data in a different way than intended. Therefore, unlimited access to the database is not possible. Only registered members have access to the Glen of Eden database.

1. Definitions

- 1.1 The Glen of Eden database contains all known data of the 'Irish Glen or Imaal Terrier' purebred.
- 1.2 The database is intended for controlled use.
- 1.3 The database is only accessible for members with a user account.
- 1.4 Members are users of the database who accepted the general terms and conditions and completed the registration truthfully.
- 1.5 A user account is a unique set of data consisting of a login code and a password with which the database can be accessed.

2. Access and registration

- 2.1 In order to become a member of the Glen of Eden database the registration must be completed truthfully.
- 2.2 Membership of the Glen of Eden database is personal and non-transferable.
- 2.3 When the registration conditions have been met, the member will be provided with a login code and a password. The login code and password are personal and strictly confidential and shall not be shared with other people.
- 2.4 If a member has reasons to believe that his/her account is used by other people, the member shall inform Glen of Eden immediately.
- 2.5 Glen of Eden reserves the right to deny candidate members access without reason.
- 2.6 Glen of Eden reserves the right to change registration and general terms and conditions without prior notice.

3. Use

- 3.1 The purpose of the Glen of Eden database is to serve as reference and provide information about pedigrees, hereditary illnesses, etcetera with regards to the 'Irish Glen or Imaal Terrier' purebred.
- 3.2 Members cannot modify data.
- 3.3 In case of inaccuracies or additions, members shall inform Glen of Eden by e-mail. Glen of Eden reserves the right to implement or not implement the suggested modification without reason.
- 3.4 The database service is free of charge.

4. Intellectual ownership

- 4.1 (Candidate) members agree that without prior written consent of Glen of Eden no material visible on and/or originating from the Glen of Eden database shall be used, edited, made public, distributed and/or reproduced.
- 4.2 The user rights granted to members by Glen of Eden are restricted to private and personal use only. All other use is prohibited without prior written consent by Glen of Eden.

5. Termination

- 5.1 Membership can be terminated at any chosen moment by simply sending an e-mail to Glen of Eden.
- 5.2 Glen of Eden reserves the right to discontinue accounts of users who have not logged into the database for at least one year.
- 5.3 In case a login code and/or password is transferred and/or distributed and/or database information is used in contradiction to the purpose of the Glen of Eden database, Glen of Eden reserves the right to terminate the user account without prior notice.

6. Liability and warranty

- 6.1 Glen of Eden cannot be held liable for direct and/or indirect losses as a consequence of information mentioned in the Glen of Eden database.
- 6.2 Glen of Eden cannot guarantee that the service is faultless and undisturbed by technical malfunction.
- 6.3 Glen of Eden will make every effort to secure the database solidly and to remedy any disturbances in the service as soon as possible.
